

End User License Agreement (“EULA”)

SOFTWARE PRODUCT LICENSE

GRANT OF LICENSE

This EULA grants you the following rights:

Hold on Tight grants you the right to install and use the software product or any portion thereof on a single computer or ECU/PCM for personal use only.
